Health Awareness - key to good health

Promoting awareness on community health issues and preventative action has been one of our focus areas. In December, we organized 10 awareness camps covering approx 1200 people (children and community people) who were educated on Oral health and hygiene, hand washing and child abuse. These camps were organized through our NGO partners in Delhi and NCR.



Vaccinations substantially reduce the occurrence of diseases

In our endeavor to protect our children against life threatening diseases, MIF under its Pan India Immunization Program completed comprehensive immunization for all 300 children of Guru Nanak Sewa Sansthan. The immunization drive which was initiated in May 2017, was successfully completed on 27th December, 2017 with all children being vaccinated against MMR, Tetanus, Hepatitis B and Typhoid.

Health Camps organised outside Delhi/NCR

- Free ENT Checkup and medicines were given to 120 children at the camp organized in association with Rotary Club, Garden City in Sonapat on 9th December. Children were also given free Dental Kits in association with Sopra Steria Foundation.
- A Multi Specialty Camp was conducted at Ukhimath on 22nd December. Doctors from MHC Dehradun reviewed 215 patients and free medicines were distributed to all.
- Multi Speciality camps were organized on 14th and 15th December in Dhakrani and Chandrothi - 342 villagers from Dhakrani and 110 villagers from Chandrothi were benefitted.



Free checkups and medicines provided for the underprivileged

12,149 needy people from the underserved communities of Delhi were given free health consultation and medicines through our partner ILA Trust (an NGO which runs 3 mobile clinic vans).



Progress in Village Dhakrani and Chandrothi

A Science centre has been set up at Dhakrani Govt High School and Guniyal Gaon Govt Intercollege with STEM Learning. It is equipped with interactive and working science models which will help to impart quality education and learning to the students.

Spreading Festive Cheer in December

To beat the winter chill, Max India Foundation donated 200 blankets to India Foundation's free clinic in Lodi Colony, New Delhi. These were distributed to the destitute and the needy. Moreover, 160 pair of shoes were also donated to children of NGO Umeed Home, Mehrauli.



Healing Touch-support for surgeries and treatments

- Max India Foundation collaborated with The Hans Foundation for supporting cancer treatment for the underprivileged in the state of Uttarakhand. The Cancer Project was started in April 2017 and so far 6 patients have been provided with treatment support (surgery/chemotherapy and radiation) at Max Hospitals.
- MIF joined hands with the Rotary Delhi Central Charitable Trust to extend financial support towards meeting the expenses for carrying out Cardiac Surgeries for children under our "Gift of Life" Project at Max Smart Hospital, Saket. So far 6 children from Kashmir have undergone successful heart surgeries.
- In the month of December, MIF sponsored CBC and Hb test for 334 children of Aasraa Trust, Dehradun.
